RE: VETO APPROVAL RAYDIENT LLC PETITION FOR ANNEXATION AND RELATED ITEMS

Attention City Clerk:

I, John F. Morrissey, Mayor of the City of St. Marys, hereby invoke my power to veto the approval of the Raydient, LLC Petition for Annexation by St. Marys City Council at the December 19, 2022 City Council meeting. I am hereby vetoing all resolutions, ordinances, and agreements that were included in the agenda item entitled "New Business Item A: Raydient, LLC Petition for Annexation." This includes the following items:

1. Annexation Ordinance including a zoning map amendment to incorporate the proposed zoning.
2. Resolution Establishing a St. Marys Tax Allocation District 2 – St. Marys Road Redevelopment Area.
3. Resolution authorizing Mayor John F. Morrissey to sign a utility agreement and mobility agreement with Raydient LLC.
4. Intergovernmental Agreement with Camden County Board of Commissioners.
5. Intergovernmental Agreement with Camden County Board of Education.
6. Resolution requesting the Camden County Public Service Authority (PSA) to issue a bond and authorize Mayor John F. Morrissey to sign an intergovernmental agreement with the PSA to effect the same.
7. Ordinance Amendment Prohibiting the Discharge of Firearms except when specified.

My authority to veto is granted to me under the City of St. Marys pursuant to Chapter 4, Section 2-405.
